

## Architectural Review Board Change Request Form

WHEREAS, on 31 July 2020, the Board of Directors of Stone Creek Property Owner's Association, Inc. ("POA") passed a resolution appointing an Architectural Review Board ("ARB") as required by the By-Laws and having been transferred architectural review and approval controls from the Developer.

The ARB exists to help ensure consistent application of design criteria and requirements included in the Covenants, Conditions, and Restrictions ("CC&Rs"), drafted with the intent of maintaining community aesthetics and thus supporting property values for all. All proposed exterior changes to homes and landscaping must be approved by this committee <u>prior to starting work</u>. Particularly, under CC&R Phase 1, Article VI.

Examples requiring approval include, but are not limited to: changes to exterior house colors, shutters, new roof, addition of living or garage / storage space, pools, patios, fences, installation of solar panels, radio towers, visible satellite dishes or electrical / mechanical equipment and cables, tree removal, or significant changes to the landscaping in your yard.

Setback stances from the side and back of the property lines and must be in compliance with ARB standards and applicable city code. Depict where electrical / mechanical bles & equipment will be installed. Outline proposed fence lines and materials, etc. Photos of chitectural elements and materials are helpful.

[	]	No work is to begin until written approval is received from the ARB.				
]	]	All requests must include site plan and drawings showing relevant information such that the ARB may fully consider the request. Simple sketches or photos may suffice depending on complexity of request. Additional documentation may be requested if your submission is incomplete, delaying a response.				
[	]	All exterior colors, materials, finishes, roofing, must be identified by manufacturer and color name / material description. Color samples must be supplied physically (not only email photo). In some cases, samples of materials may be needed to fully consider the request.				
[	]	Most requests take approximately 14 days to review and could be longer if all needed information is not available. Note the CC&Rs state the ARB must respond within 60 days. Please plan accordingly.				
[	]	Property owners are responsible for contacting the City of Fairhope, Baldwin County, local utilities, and other appropriate agencies for permits, setback requirements, surveys, inspections, and other such items. Approval by the ARB is *not* a guarantee or representation of proper design, good workmanship, or compliance with local regulations.
